Nomination & Election of 2022-2023 MLS Committee

Thank you for your interest in serving on the MLS Committee, which is comprised of nine (9) Participants and two (2) Subscribers, who are elected to serve staggered, two-year terms. No more than three (3) members of the MLS Committee may be from the same firm, partnership, corporation or limited liability company. Your application will be provided to the MLS Nominating Committee for their consideration in preparing the ballot.

Purpose of the MLS Committee: To establish and maintain policies and procedures for the MLS system and MLS data provided to the MLS by its Participants and Subscribers. As different technologies become more readily available to REALTORS®, the MLS Committee will be responsible for decisions regarding updates to the system, and the manner in which the multiple listing service is utilized, in order to maintain the integrity of the systems while not limiting the creativity and profitability of the Participants.

Commitments & Expectations

- The MLS Committee meets monthly on Thursdays from 9:00-10:30 am. The 2022 MLS meeting dates are: February 24, March 3, April 7, May 12, June 2, July 7, August 4, September 1, October 6, November 3, and December 1.
- Absence from three (3) regular meetings in a calendar year shall be construed as resignation.

Preparation of Ballot: The Nominating Committee shall:

- Strive but is not required to avoid putting forth persons who, if elected, would be serving more than two (2) consecutive terms.
- Give consideration but is not limited to Participants/Subscribers, who (a) have no less than 2 years of participation in/subscription to the MLS prior to the date of their election; (b) are actively involved in listing/selling real property; and/or (c) serving in a management role overseeing those who list/sell real property.

Timeline for Election

- Friday, February 11, 5:00 pm – Deadline to submit applications to carol@gcar.net.
- Week of February 14 – Nominating Committee announces the ballot and online voting opens to the MLS Participants.
- February 23 – Election results announced.
- February 24, 9:00 am – Election winners should plan to attend the MLS meeting.

***While the MLS Committee is comprised of both Participants and Subscribers, the election is conducted by a vote among the Participants.**
